

3. No later than July 31, 2016, the Hillsborough County Supervisor of Elections sent Appellant a Notice of Delinquency by certified mail. This notice was also sent to the 190 NE 199th Street address. The notice was returned by the Post Office marked "Return to Sender, No Such Number – Unable to Forward."

4. On August 17, 2016, the Commission mailed Appellant a postcard intended to remind her of her obligation to file a 2015 CE Form 1. The Commission mailed the postcard to the 190 NE 199th Street address. The postcard was returned by the Post Office marked "Return to Sender, Undeliverable As Addressed – Unable to Forward."

5. On September 7, 2016, six days after the grace period expired, the Commission mailed Appellant a courtesy notice informing her that an automatic fine had begun to accrue. The Commission mailed this notice to the 190 NE 199th Street address. The notice was returned by the Post Office marked "Return to Sender, Undeliverable As Addressed – Unable to Forward."

6. On September 13, 2016, Commission staff spoke with the Financial Disclosure Coordinator and obtained a new address for Appellant at 1119 Oxbridge Drive, Lutz, FL 33549.

7. On September 15, 2016, the Commission resent Appellant the courtesy notice informing her that an automatic fine had begun to accrue. The Commission mailed this notice to the 1119 Oxbridge Drive address.

8. On September 26, 2016, Appellant submitted her 2015 CE Form 1 to the Commission on behalf of the Hillsborough County Supervisor of Elections.

9. The amount of fine automatically assessed against Appellant was \$625.

10. On February 20, 2017, the Commission mailed a Notice of Assessment of Automatic Fine to the 1119 Oxbridge Drive address. This mailing indicated the total of Appellant's accrued automatic fine. The mailing also included a notice of her right to appeal the fine.

11. On March 20, 2017, Appellant submitted her appeal to the Commission. In her appeal, Appellant states that she was unable to timely file her disclosure form due to lack of notice. Appellant states that she did not receive any of the notices sent by the Hillsborough County Supervisor of Elections or the Commission regarding her financial disclosure obligation because her job required her to work in Kissimmee, and her mail was not forwarded to her in a timely manner. She further states that once she became aware of her filing obligation, she immediately filed her financial disclosure.

Conclusions of Law

12. The Commission has jurisdiction over the subject matter of this proceeding pursuant to Section 112.3145, Florida Statutes.

13. Financial disclosure is required of public officials and employees because it enables the public to evaluate potential conflicts of interest, deters corruption, and increases public confidence in government. In order to increase compliance, beginning in 2001 the Legislature provided for an automatic fine of \$25 per day, up to a cap of \$1,500, on persons who do not timely file their financial disclosure statements. Under the law, the Legislature permitted the Commission to waive a fine only "based upon unusual circumstances surrounding the failure to file on the designated due date"

14. Commission Rule 34-8.215, F.A.C., defines "unusual circumstances" as follows:

uncommon, rare or sudden events over which the reporting individual has no control and which directly result in the failure to

act in accordance with the filing requirement. Circumstances which allow for time in which to take those steps necessary to assure compliance with the filing requirement shall be deemed not to constitute unusual circumstances.

15. Appellant's basis for the appeal of her fine is that is that she did not receive any of the notices sent to her by the Hillsborough County Supervisor of Elections or the Commission regarding her obligation to file the 2015 CE Form 1 or the fine. Appellant's claim is supported by the fact that all of the notices sent to her by the Hillsborough County Supervisor of Elections and the Commission were returned as undeliverable due to a bad address. It was not until the Commission resent the courtesy notice informing her that an automatic fine had begun to accrue to her new address that Appellant apparently first received notice of her financial disclosure obligation. Appellant then immediately filed her 2015 CE Form 1. Appellant's basis for the appeal of her fine, that she did not receive notification of her obligation to file the 2015 CE Form 1, constitutes an "unusual circumstance" that justifies waiving the \$625 fine.

Order

Based on the foregoing facts and conclusions of law, the Commission hereby waives the assessed fine of \$625.
