



3. No later than July 31, 2016, the Broward County Supervisor of Elections sent Appellant a Notice of Delinquency by certified mail. This notice was also sent to the 4837 NW 104<sup>th</sup> Lane address. The notice was returned by the Post Office marked "Undeliverable as Addressed, Return to Sender."

4. On August 17, 2016, the Commission mailed Appellant a postcard intended to remind him of his obligation to file a 2015 CE Form 1. The Commission mailed the postcard to the 4837 NW 104<sup>th</sup> Lane address.

5. On September 7, 2016, six days after the grace period expired, the Commission mailed Appellant a courtesy notice informing him that an automatic fine had begun to accrue. The Commission mailed this notice to the 4837 NW 104<sup>th</sup> Lane address.

6. On September 12, 2016, Appellant submitted his 2015 CE Form 1 to the Broward County Supervisor of Elections. The disclosure form listed Appellant's address as 5621 NW 117<sup>th</sup> Avenue, Coral Springs, FL 33076.

7. The amount of fine automatically assessed against Appellant was \$275.

8. On March 15, 2017, the Commission mailed a Notice of Assessment of Automatic Fine to the 4837 NW 104<sup>th</sup> Lane address by certified mail. This mailing indicated the total of Appellant's accrued automatic fine. The mailing also included a notice of his right to appeal the fine. The notice was delivered and signed for by someone at the 4837 NW 104<sup>th</sup> Lane address.

9. On April 24 2017, Appellant submitted his appeal to the Commission. The appeal listed Appellant's address as 5621 NW 117<sup>th</sup> Avenue, Coral Springs, FL 33076. In his appeal, Appellant claims that he timely filed his disclosure form. Appellant further claims that he failed to timely file his disclosure form due to "other unusual circumstances." In support of his claim,

Appellant submitted a sworn affidavit stating that he filed his required financial disclosure in August 2016, and, after receiving a notice from the financial disclosure coordinator, re-mailed his financial disclosure form to the Broward County Supervisor of Elections in late August 2016, prior to the filing deadline. Appellant's sworn statement also states that he recently completed a very difficult divorce and, as a result, moved from the 4837 NW 104<sup>th</sup> Lane address in August 2016, the same month that he filed his 2015 CE Form 1.

#### Conclusions of Law

10. The Commission has jurisdiction over the subject matter of this proceeding pursuant to Section 112.3145, Florida Statutes.

11. Financial disclosure is required of public officials and employees because it enables the public to evaluate potential conflicts of interest, deters corruption, and increases public confidence in government. In order to increase compliance, beginning in 2001 the Legislature provided for an automatic fine of \$25 per day, up to a cap of \$1,500, on persons who do not timely file their financial disclosure statements. Under the law, the Legislature permitted the Commission to waive a fine only "based upon unusual circumstances surrounding the failure to file on the designated due date . . . ."

12. Commission Rule 34-8.215, F.A.C., defines "unusual circumstances" as follows:

uncommon, rare or sudden events over which the reporting individual has no control and which directly result in the failure to act in accordance with the filing requirement. Circumstances which allow for time in which to take those steps necessary to assure compliance with the filing requirement shall be deemed not to constitute unusual circumstances.

13. Appellant was notified of his appellate rights on March 15, 2017, and informed his appeal needed to be received by the Commission on Ethics on or before April 14, 2017, in accordance with the 30-day appeal period allowed by Section 112.3145(7)(f)3., Florida Statutes.

Appellant did not timely file an appeal. Appellant then filed his appeal on April 24, 2017, which was outside the 30-day appeal window. However, he claims he never received the notice concerning his appeal, which was sent on March 15, 2017. Based on Appellant's sworn statement, he did not reside at the address where the notice concerning his appeal was mailed. As a result, there is no evidence that he actually received the notice prior to the filing deadline. In this circumstance, it is not unreasonable to assume that Appellant did not actually receive the notice. For this reason, his appeal is accepted as timely filed.

14. Appellant's basis for the appeal of his fine is that he submitted his 2015 CE Form 1 in a timely manner when he mailed it before the filing deadline. Based on the sworn representation submitted in this appeal, Appellant timely completed and mailed his 2015 CE Form 1 to the Broward County Supervisor of Elections, but its non-receipt was an "unusual circumstance" that justifies waiving the \$275 fine.

Order

Based on the foregoing facts and conclusions of law, the Commission hereby waives the assessed fine of \$275.


