THIRD ORDER ON REQUEST FOR EXTENSION

The Commission on Ethics has received a request for an extension of time to file a CE Form 1, Statement of Financial Interests, on behalf of the above-referenced individual who, as a member of the Board of Pension Trustees for the East Lake Tarpon Special Fire Control District, was required to file a 2014 CE Form 1 no later than September 1, 2015. The request for an extension of time for Mr. Dibert to file his 2014 CE Form 1 states that he is currently unable to complete the Form as he is suffering from a rapid onset of vascular dementia. Based on this request, the Chair previously granted an extension through October 19, 2015, and the Commission granted a second extension until March 4, 2016, although the request indicates a further extension is needed as Mr. Dibert is still suffering from dementia.

Section 112.3151, Florida Statutes, allows the Commission to grant, for good cause, an extension of time for filing disclosure. Good cause having been shown, the request is hereby GRANTED, and Mr. Dibert shall have until and including December 31, 2016, to file his 2014 CE Form 1. This extension will apply *nunc pro tunc* to and including March 5, 2016. *Should Mr. Dibert require another extension, he should notify the Commission no later than November 20, 2016, to allow adequate time to process his request.*


