Attached is a sample final order that formally imposes the statutory, automatic fines associated with missing the financial disclosure filing deadline. These final orders represent final agency action and close the Commission's proceedings for the individuals listed in this packet, all of whom (1) failed to file or failed to file timely their 2020 and/or 2021 financial disclosure forms, (2) have not appealed their fines or have had their fines affirmed on appeal; and (3) have not already paid the fines.

With your approval, staff will process default final orders for each person on the list, consistent with the attached sample final order. Pursuant to the order, upon the expiration of the 30-day period, those currently receiving public funds will be referred for salary withholding. All others will be transmitted to Transworld System, Inc., a collection agency contracted by the Department of Financial Services, for collection.

# **DEFAULT FINAL ORDER**

This matter comes before the Commission on Ethics for the failure of John Polinsky to pay the assessed fine. Pursuant to Section 112.3145(8)(f), Florida Statutes, the Florida Commission on Ethics is charged with assessing automatic fines of \$25 per day up to a maximum of \$1500 for persons who are required to file financial disclosure but who either file late, or not at all.

## FINDINGS OF FACT

- 1. John Polinsky, Dorcas Fire District, Board of Commissioners, was on the list of persons required to file a Statement of Financial Interests for the year 2020.
- 2. Pursuant to Section 112.3145(8)(f), Florida Statutes, John Polinsky was mailed a copy of the 2020 CE Form 1 no later than June 1, 2021, and was mailed a delinquency notice by certified mail no later than July 31, 2021. Additional attempts to contact JOHN POLINSKY were also made by Commission staff.
- 3. However, John Polinsky did not file a 2020 CE Form 1 by the designated due date. John Polinsky was sent a notice of payment due advising of the statutory rights to appeal or dispute the automatic fine in a hearing before the Commission if such appeal was received within 30 days of the notice of payment due. No timely appeal was received from JOHN POLINSKY.

- 4. More than 60 days have elapsed since the notice of payment due was transmitted without John Polinsky paying the fine.
- 5. On its own motion, the Commission voted to affirm that a fine in the amount of \$1500 has accrued in this matter.

### CONCLUSIONS OF LAW

- 6. The Commission has jurisdiction over the parties to and subject matter of this case, pursuant to Section 112.3145, Florida Statutes.
- 7. John Polinsky's failure to timely appeal the assessed fine constitutes a waiver of the entitlement to an appeal, pursuant to Rule 34-8.215(2), Florida Administrative Code.

#### ORDER

- 8. Pursuant to Section 112.3145(8) and 112.31455, Florida Statutes, the Commission on Ethics shall attempt to determine whether John Polinsky is currently a public officer or public employee receiving salary or wages from a governmental entity. If so, the matter will be referred to either the Chief Financial Officer for the State of Florida or the governing body for Dorcas Fire District, as appropriate, for withholding of salary until the debt is satisfied.
- 9. If John Polinsky is no longer a public officer or employee, or if the Commission cannot determine filer's status, the matter will be referred to the Florida Department of Financial Services for collection or wage garnishment.

WHEREFORE, the automatic fine that John Polinsky accrued in the amount of \$1500 is affirmed. The fine shall be paid to the Florida Commission on Ethics within 30 days of the date this Default Final Order is entered. After that date, nonpayment will result in collection as provided for in Section 112.3145(8) and 112.31455, Florida Statutes.
