FINAL ORDER

This matter came before the Commission on Ethics, meeting in public session on April 25, 2025, on the timely appeal of The Policy Standard LLC, pursuant to Section 112.3215(5)(d), Florida Statutes, which assesses an automatic fine of \$50 per day on a lobbying firm that fails to timely file an executive branch compensation report. The Commission may waive the fine in whole or in part for good cause shown, based on unusual circumstances surrounding the failure to file by the designated due date. Appellant has requested a hearing before the Commission.

Findings of Fact

- 1. Appellant is a lobbying firm that receives, or is entitled to receive, compensation for the purpose of lobbying agencies of the executive branch and is required to file a firm compensation report with the Commission on Ethics for each calendar quarter during any portion of which one or more of the firm's lobbyist(s) were registered to represent a principal.
- 2. During the fourth quarter of calendar year 2024, Appellant had two registered lobbyists. The statutory deadline for the filing of the executive branch firm compensation report for the fourth quarter of 2024 was February 14, 2025.

- 3. On January 1, 2025, Appellant was sent an email reminder regarding the requirement to file its fourth quarter compensation report, which indicated the deadline for filing was February 14, 2025, at 11:59 p.m. EST.
- 4. On February 9, 2025, Appellant was sent a follow up courtesy reminder at the same email address regarding the requirement to file the firm's fourth quarter compensation report. The email also indicated that the deadline for filing was February 14, 2025, at 11:59 p.m. EST. Commission records indicate this second email was marked as "Bounced-Undeliverable."
- 5. On March 17, 2025, following several attempts to contact Appellant by email and phone, Appellant filed its fourth quarter compensation report. The amount of the fine automatically assessed against Appellant was \$1,550, reflecting that the report was filed 31 days late. The report indicated \$0 total compensation for the fourth quarter of 2024.
- 6. That same day, March 17, 2025, Appellant was sent a Notification of Assessed Fine via email. The Notification was sent to the same address as the earlier reminders. The Notification included the total amount of Appellant's accrued automatic fine. The Notification also included a notice of Appellant's right to appeal the fine.
- 7. Approximately five minutes after the Notification of Assessed Fine was sent, one of Appellant's registered lobbyists contacted the Commission's representative by telephone and indicated he had just filed Appellant's fourth quarter compensation report. The registered lobbyist indicated he planned to appeal any fine imposed, and "said he [had] ceased lobbying and [had] 'closed' The Policy Standard LLC."

¹ Section 112.3215(5)(d)4, Florida Statutes, provides for a one-time fine waiver the first time a lobbying firm fails to timely file an executive branch compensation report, so long as that report is filed within 30 days of the late notice. Appellant received this one-time fine waiver in association with a late-filed third quarter 2024 executive branch compensation report and is not eligible to receive another automatic fine waiver.

8. Later that same day, March 17, 2025, Appellant submitted an appeal of the automatic fine. In its appeal, Appellant stated as grounds that it had ceased all executive branch lobbying activities prior to the fourth quarter of 2024 and that no lobbying activity had been conducted during the reporting period. Appellant indicated that "[d]ue to the closure of the firm's lobbying operations, the reporting requirement was inadvertently overlooked," which it claimed was "beyond [its] control[.]"

Conclusions of Law

- 9. The Commission has jurisdiction over Appellant and over the subject matter of this proceeding pursuant to Section 112.3215, Florida Statutes.
- 10. Section 112.3215(5)(d), Florida Statutes, assesses a fine of \$50 per day on an executive branch lobbying firm that fails to timely file a compensation report and provides that the Commission may waive the fine in whole or in part for good cause shown, based on "unusual circumstances surrounding the failure to file on the designated due date."
- 11. Commission Rule 34-12.407(4), Florida Administrative Code, defines "unusual circumstances" as follows:
 - 'Unusual circumstances' means uncommon, rare or sudden events over which the actor has no control and which directly result in the failure to act in accordance with the filing requirements. Circumstances which allow for time in which to take those steps necessary to assure compliance with the filing requirements shall be deemed not to constitute unusual circumstances.
- 12. The responsibility for timely filing of executive branch compensation reports rests with the lobbying firm, as does the burden of persuading the Commission that the failure to timely report resulted from "unusual circumstances."
- 13. Appellant asserts in its appeal that there were "unusual circumstances" justifying the waiver of its fine, claiming it "inadvertently overlooked" the requirement to file the fourth

quarter compensation report as it had ceased its executive branch lobbying activities prior to the reporting period. Despite Appellant stating that any oversight concerning filing the fourth quarter compensation report was "an uncommon and rare occurrence beyond [its] control[,]" we do not find Appellant has provided grounds constituting "unusual circumstances," as is needed to waive the fine.

- Initially, we note that, even if Appellant had ceased its executive branch lobbying 14. activities, it remained a registered executive branch lobbying firm and, for this reason, was still required to timely submit a report. The statute concerning compensation reports requires a quarterly filing from registered lobbying firms even when no compensation is received. See Moreover, Rule 34-12.340 of the Florida Section 112.3215(5)(a)1.c., Florida Statutes. Administrative Code sets out the procedure when a lobbying firm wants to cancel their registration, stating "[s]uch cancellation must be provided promptly by written notice to the Commission and until received, the lobbying firm will continue to be responsible for filing all (emphasis added). See also § 112.3215(7), Fla. Stat. required compensation reports." Therefore, even accepting as true that Appellant had ceased its executive branch lobbying activities prior to the fourth quarter and conducted no lobbying during that period, this does not automatically excuse its failure to timely file the report, considering that it remained a registered lobbyist.
- 15. Moreover, Commission records show that Appellant received timely notice of its filing obligation. An email sent to Appellant on January 1, 2025, clearly indicated the deadline for filing the fourth quarter compensation report and stated that fines of \$50 per day would accrue if the report was untimely. While there appears to have been delivery issues with the other email sent to Appellant prior to the deadline, our records show this initial email was

successfully delivered. Also, Commission records indicate Appellant had, just weeks before,

used its one-time statutory waiver regarding the untimely filing of its third quarter compensation

report, which underscores that Appellant was on notice of its filing requirement. This waiver

would have occurred in the fall of 2024, immediately prior to when the fourth quarter report in

question was due.

16. In short, as a registered lobbyist, Appellant owed a fourth quarter compensation

report and had received clear notice of this requirement prior to the filing deadline. While it

claims it "inadvertently overlooked" its filing requirement, this type of administrative oversight

on its part—even if unintentional—does not constitute an "uncommon, rare, or sudden"

occurrence that justifies waiving the fine, especially considering that it had been recently

informed of its filing obligation. For these reasons, we find Appellant has failed to demonstrate

that its untimely filing of the fourth quarter executive branch compensation report resulted from

"unusual circumstances," and we therefore affirm the fine in this matter.

Order

Based on the foregoing facts and conclusions of law, the Commission hereby affirms the

assessed fine of \$1,550.

I am writing to formally appeal the \$1,550.00 late filing fine imposed on Policy Standard LLC for the 2024 Legislative report, pursuant to Section 112.3215(5)(d)5., Florida Statutes, and Rule 34-12.407, Florida Administrative Code. I respectfully request that the fine be waived based on the presence of unusual circumstances that prevented timely filing.

Policy Standard LLC ceased all lobbying activities prior to the reporting period, and no lobbying activity was conducted during the timeframe covered by the report. 
